Get FIT, Go Green and Make Money

Are you curious about rooftop solar electricity generation? Have you heard that Ontario's microFIT program will allow you to develop a renewable energy generation project, feed electricity back into the grid and be paid for it? Exciting stuff! And REAL is bringing two presentations to Smiths Falls to help people learn more about the program and how to proceed.

The Green Energy Act launched October 1, 2009 is intended to position Ontario as a global leader in the field of renewable energy, clean distributed energy and conservation. In doing so it will be creating economic prosperity, increased energy security, and green jobs. It will allow the eventual closure of coal power plants, creating environmental benefits, including reducing our impact on climate change.

The act paves the way for businesses, farm and home owners, or communities of participants to enter the renewable energy market by obligating utilities to purchase power from green energy projects. Two programs, FIT and microFIT, managed by the Ontario Power Authority, make it easier for small producers to become involved in generating electricity, and introduce stable and generous purchase prices to encourage producers to enter the market.

FIT is directed at producers of over 10 kilowatts, and microFIT is directed at producers of less than 10 kilowatts. While the FIT program applies to all renewable energy technologies - biogas, biomass, landfill gas, solar PV, water power and wind - it is expected that rooftop solar

photovoltaic (PV) systems will be the most common microFIT project. With rates set at 80.2 (c/kWh) for solar produced electricity, it is certainly the most attractive purchase price.

The first presentation on Wednesday March 10 will be by SWITCH, a non-profit, sustainable energy association serving southeastern Ontario. Switch has received federal funding to provide information and support to small and medium enterprises wanting to get into the renewable energy market, as well as to support citizens by educating and enabling them to take advantage of programs such as microFIT. They will cover the Green Energy Act, the Feed in Tariff (FIT) program, and the advantages to Eastern Ontario businesses and homeowners.

Both presentations will start at 7 p.m. in the auditorium of the Rideau Canal Museum, 34 Beckwith St. S., Smiths Falls. Both are free, but donations are always appreciated. Physical Challenges at REAL Deal - We Need a Property Manager

We are forging ahead with the physical upgrades made possible by a Trillium Foundation grant. It is wonderful to have a functioning kitchen sink and a utility sink to use. They will go a long way to keeping the store and sale items cleaner. A bright yellow awning for the customer entrance has been ordered, and we will be moving on the loft flooring and office area windows within the next couple months.

Unfortunately, keeping these projects moving and ongoing maintenance at the building were a REAL challenge in December. Nothing goes as smoothly as it should! The installation of the propane furnace, removal of the old furnace, and getting established with a propane supplier did create some difficulties. We had problems with our locks, a problem with our baseboard heaters, an electrical safety issue, a computer modem failure, a shelf that fell over causing much breakage, and a mouse problem. And then the winter thaw caused flooding in the store January 25, which of course required immediate attention. None of these was super serious, but the problems were certainly aggravating and time consuming, and they drain human resources away from what REAL needs to be doing.

REAL would really like to find a property manager to help us deal with problems relating to the physical operations of the REAL Deal building. The volunteer position would be ideal for someone who is somewhat handy, likes to putter, is mobile, lives nearby and is reasonably free during the daytime. This person wouldn't have to physically do all the fixing, but would advise on the appropriate course of action, and meet with and select contractors when necessary. While you're there, take a look at the Recyclopedia of area businesses and organizations that take back products for reuse or recycling. Brockville.Reuses uses the same system provided by iWasteNot, and is administered by the Brockville Climate Action Group.

Keeping the Money Rolling In

Home Air Quality Rates More Attention

Air pollution is a serious issue, but for your personal health, pay more attention to your indoor air quality! Urban dwellers spend about 90% of their time inside: in the home, at work, and other places.

Broadly speaking, there are biological pollutants and chemical pollutants. Biological pollutants are living organisms like mould, bacteria and dust mites. Chemical pollutants are gases and particles that come from combustion appliances, tobacco smoke, household and personal care products.

Some things you can do to avoid the biological pollutants are to control the humidity in your home by using ventilation, venting your drier to the outside, and using a dehumidifier if necessary. To keep dust mites in check, avoid carpet and draperies, wash bedding in hot water, and encase mattresses and pillows and plastic.

The chemical pollutants can be harder to avoid because they come from so many sources. One of the major classes of indoor pollutants are volatile organic compounds (VOC's) that offgas from petroleum based products. And there are thousands of them, including furniture, carpeting, varnishes, synthetic building materials, air fresheners, cleaning solutions, personal care products, tobacco smoke, pesticides, solvents in inks and adhesives.

VOCs are emitted as gases from certain solids or liquids, and can have short- and long-term adverse health effects. Some cause asthma, impaired lung function, and damage to liver and kidneys. Mixtures of VOCs are thought to be the cause of Sick Building Syndrome; its symptoms include heeadaches, nausea, and ear, eye, nose and throat irritation. Still others are carcinogens, such as the benzene in tobacco smoke, perc in dry cleaning fluid and fomaldehyde in pressed wood products.

About a dozen common VOC's are consistently

found at two to five times higher levels inside homes than out. And some of the safer ones react with each other to make unsafe compounds.



So here are some things you can do to minimize your exposure and protect your indoor air quality.

- Don't smoke or allow anyone to smoke indoors.
- Vacuum and dust regularly with a damp cloth.
- Use latex paints and VOC free paints.
- Select natural fibre carpets, and avoid adhesives.
- Use homemade cleaners (vinegar, baking soda, lemon juice) instead of purchased ones.
- Carefully maintain any combustion appliances, including fireplaces and chimneys, to avoid carbon monoxide.
- Do not idle your vehicle in an attached garage.
- If you must use a pesticide indoors, ventilate and limit your exposure.
- Minimize your exposure to perc (percholorehtylene) emissions from newly dry-cleaned materials.
- Try to purchase low or no VOC products.
- Consider purchasing reused materials whose VOC's have already off-gassed.
- Use plenty of ventilation when painting, remodelling or using products that may release VOCs, as the elevated concentrations may persist in the air long afterward.
- Properly store chemicals as gases can leak even from closed containers
- Buy chemicals in small quantities only as needed
- Discard unneeded chemicals safely with your other hazardous waste

End of Home Reno Tax Credit not the End of Reno Financial Help


The end of the Home Renovation Tax Credit (HRTC) doesn't mean there still isn't financial help for a range of home renovation projects. The ecoEnergy program, which actually pays back between 25-33%, instead of just the maximum 13% of the HRTC, will help you install a new furnace, do insulation and air sealing, install a solar domestic hot water heater and many, many more energy efficiency improvements.

This program is scheduled to end in March, 2011, so now is the perfect time to be scheduling the pre audit, getting the work done, so as to be able to do the post-audit before the end of the program, and get grants back.
