- 1. Welcome Katie Hoffman, President opened the meeting, read an indigenous land acknowledgement and introduced the board members and other participants.
- 2. Katie introduced our guest speaker, Phil Mosher, Planner with the Rideau Valley Conservation Authority (RVCA).
- 3. Urban Stormwater Management. Phil delivered a 15-20 minute presentation entitled "Stormwater Management: A Brief Overview" that provided an overview of the hydrologic cycle and the work of Conservation Authorities, the difference between urban and rural stormwater runoff, and some individual actions that could be taken to manage it.
